AN ORDINANCE TO DESIGNATE AN ENFORCING AGENCY TO DISCHARGE THE RESPONSIBILITY OF BENTON TOWNSHIP, HEBRON TOWNSHIP, INVERNESS TOWNSHIP AND MACKINAW TOWNSHIP, CHEBOYGAN COUNTY, MICHIGAN AND TO DESIGNATE REGULATED FLOOD HAZARD AREAS UNDER THE PROVISIONS OF THE STATE CONSTRUCTION CODE ACT, ACT NO. 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED.

The Townships of Benton, Hebron, Inverness and Mackinaw located in Cheboygan County, Michigan ordain:

#### Section 1 Agency Designated

This section sets forth the agency that is designated to enforce the state construction code within the Township.

#### Section 2 Code Appendix Enforcement

This section sets forth that Appendix G of the Michigan Building Code shall be enforced by the Cheboygan County Building Official within the Township.

#### Section 3 Designation of Regulated Flood Prone Hazard Areas

This section adopts the Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled "Cheboygan County" and the Flood Insurance Rate Map(s) for the respective Townships for the purposes of administration of the Michigan Construction Code.

#### Section 4 Repeals

This section repeals any Ordinances that are inconsistent with the provisions of this Ordinance.

#### Section 5 Effective Date

This section provides that the Ordinance shall become effective the day following publication.
